Re: Certification of New Interstate Natural Gas Facilities, Docket No. PL18-1-00

Dear Ms. Bose:

On February 18, 2021, the Federal Energy Regulatory Commission (FERC) issued a Notice of Inquiry (NOI) in the above-captioned proceeding. In the NOI, FERC asked interested parties to submit additional information and perspectives on potential revisions to the current Policy Statement for the certification of new interstate natural gas facilities under Section 7 of the Natural Gas Act and 18 C.F.R. Part 157. GPA Midstream Association¹ (GPA Midstream) is submitting the following brief comments in response to the NOI.

In making any changes to the current Policy Statement, GPA Midstream believes that FERC's primary focus should be on encouraging the prompt and responsible development of interstate gas pipeline facilities. These facilities are a necessary and critical part of our nation's energy infrastructure and are the safest and most effective means of transporting natural gas. FERC should avoid adopting unnecessary barriers to the development of new interstate gas pipeline projects and seek ways to streamline the certificate process. FERC should not inject additional regulatory uncertainty into the process by requiring open-ended or unduly expansive environmental reviews.

GPA Midstream otherwise supports the detailed comments submitted by the Interstate Natural Gas Association of America in this proceeding. GPA Midstream appreciates the
